

## ANNOUNCING THE THIRD PILLAR

As was demonstrated in the first pillar, the presence of observers has been totally ignored when facing an autonomous, dynamic and synchronized Universe through an ‘absolute Time’, independent of the observer.

In the beginning of the XX century (1905), with the publication of the Relativity Theory by A. Einstein, Physics was supported by one more pillar, that is because not only it brought back the observer in to the scene, it formulated and proved the existence of a physical ‘Space-time’, which curves when in proximity of large gravitational masses. ‘Time’ then became ‘relative’, as it depends on the ‘viewpoint’ of the observer.
